

TERMS AND CONDITIONS CASH REBATE PROMO



Terms and Conditions - Cash Rebate Promo

Exelium Ltd (hereinafter referred as "**Exelium**" or "**the Company**") offers a Cash Rebate Promotion (hereinafter referred to as "**the Promotion**") subject to the terms and conditions contained herein.

The Promotion is available to clients provided that they are eligible to participate in the Promotion subject to the Company's eligibility criteria as indicated in the <u>Client Services Agreement</u> and these terms.

For participating in the Promotion, the participants should have already completed the steps required for opening a trading account with the Company and they should have also completed the client due diligence and KYC process as well as the participants have their account activated.

Conditions of the Promotion:

- 1. Only applicable to verified clients of Exelium trading on the MT5 trading platform.
- 2. The Promotion starts on February 26, 2024, and ends on May 31, 2024, at midnight (trading server time).
- 3. To participate in the Promotion, participants need to create an MT5 trading account and trade at least 1 lot in the following instruments: Forex/Currency Pairs, Metals, Gold and Silver.
- 4. Existing clients need to open a new MT5 account and inform support at support@exelium.com of the account number to manually link the account to this Promotion.
- 5. Participants need to make new deposit of at least 200 USD. Note that Internal transfers between trading accounts will not be considered as a new deposit.
- 6. The trades should be opened for at least 3 minutes to be eligible to participate in the Promotion. Any trades below 3 minutes will be disqualified.
- 7. The more trades in the above symbols, the higher the rebates, depending on the account type, which is presented below:

Account Type	Cash Rebate per lot	Example Paid Rebates
Classic	\$ 5	\$37.5 (7.5 lots x \$5)
Premium Spreads	\$ 2	\$80 (40 lots x \$2)
VIP	\$ 1	\$36 (36 lots x \$1)
Powerful Leverage	\$ 6	\$183 (30.50 lots x \$6)

8. You will be paid for each traded lot to be kept open for a minimum of 3 minutes. For example, if you trade 40 lots on a Premium Spreads account, your cash rebates will be: $40 \times \$2 = \80.00

- 10. Cash Rebates will be credited to Client's trading account immediately after closing each position.
- 11. Cash rebates can be traded or fully withdrawn with no limitations.
- 12. The accounts in the Cash Rebate Promotion do not generate IB commissions.
- 13. By participating to the Promotion, the Client acknowledges that s/he has read and agreed to be bound by these Terms and Conditions as well as to the <u>Client Services Agreement</u>.
- 14. To participate in the competition new clients will need to complete Exelium' registration form, complete their Economic profile and upload the required documents in the Client Portal to verify their profile.
- 15. The Company will not be liable for any stop outs or any other consequences that result out of a Bonus cancellation and/or removal (where applicable).
- 16. If the Company suspects that a participant has abused the rules of the Promotion and/or has been identified to have engaged in abusive trading behaviour in any way, then the Company reserves the right at any time and at its sole discretion to immediately exclude the participant from the Promotion and take additional actions depending on the abuse.
- 17. The Company will be entitled to (list not exhaustive):
 - a) deny, withhold, or withdraw from that participant the credit bonus and any profits generated from the abusive trading behaviour*.
- 18. The Company reserves the right to modify or cancel the Promotion at any time and at its sole discretion or cease this Promotion without any prior notice.

- multiple profiles

- failure by the client to meet certain requests by the Company related to the Promotion within the specified deadline provided in the correspondence with the Company
- the participation to the Promotion of third parties on behalf of the IB without the proper authorization or right to act
- · trades entered or exited with latencies
- opening and closing a trade in under 3 minutes
